The Vendor has the absolute right to withdraw from the sale of the Property at any time before the acceptance of any offer to purchase the Property. The Vendor has the absolute right to change the tender closing date, time of the tender and/or the Place of Tender Submission from time to time by amending the Information on Sales Arrangements in relation hereto.
